FOODIE FRIDAYS DIGITAL FACEBOOK COMPETITION TERMS & CONDITIONS

1. Customers may enter by commenting on Coolalinga Central's official Foodie Fridays competition social media posts.
2. The campaign commences on **Friday 4 July 2025** and concludes on **Friday 21 November 2025**, with a new competition round running every fortnight. Each draw period begins on a Friday and ends on a Friday two weeks later. Specific dates will be outlined on each individual competition post.
3. Prizes will vary for each competition round and may include but are not limited to:
 - Two (2) x \$25 Foodie Fridays Gift Cards (total value \$50)
 - Store-specific vouchers
 - Coffee or food items from participating Coolalinga Central retailers
4. Details of each specific prize will be outlined in the corresponding competition post.
5. The total prize value will be stated clearly in each competition post.
6. One (1) winner will be selected at random and notified via Private Message from the official Coolalinga Central Facebook or Instagram account.
7. Entrants must be 18 years or over to enter.
8. The prize will need to be collected within one (1) week from Coolalinga Central's Centre Management Office during business hours.
9. The following persons are not eligible to enter the competition:
 - Tenants of Coolalinga Central
 - Employees of tenants of Coolalinga Central
 - Contractors of Coolalinga Central and their employees
 - Immediate family members of any of the above i.e. spouses and children.

11. The winner agrees to have their name used for advertising purposes.
12. The competition will be drawn by a representative of Centre Management, whose decision will be final, and no correspondence will be entered into.
