

FATHER'S DAY DIGITAL FACEBOOK COMPETITION TERMS & CONDITIONS

- 1. Customers may enter by completing the online form on Coolalinga Central's official Father's Day competition social media posts or website.
- 2. The competition commences on Tuesday 19 August. The competition will close on Tuesday 2 September at 3.00pm. The draw will take place shortly after.
- 3. The prize includes one (1) \$100 Tackle World Coolalinga Voucher and one (1) \$100 Beta Coolalinga Butchers Voucher.
- 4. The total prize is valued at \$200.
- 5. The one (1) winner will be notified by telephone including instructions for prize collection.
- 6. Entrants must be 18 years or over to enter.
- 7. The prize will need to be collected within one (1) week from Coolalinga Central's Centre Management Office during business hours.
- 8. The following persons are not eligible to enter the competition:
